Please find attached the quarterly Community Policing Report that covers the January 1st to March 31st, 2023 reporting period. This information serves to provide a quarterly snapshot of the human resources, financial data and crime statistics for Barrhead Detachment. The sharing of quarterly reports demonstrates our ongoing commitment to transparency while delivering the high level of policing services that you, and the citizens you represent, have come to expect from the Alberta RCMP.

As we transition towards Spring, the safety and security of all Albertans will continue to be our main focus. In an effort to leverage technology to oversee and amplify our response to emergency incidents around the Province, your Alberta RCMP recently established a Real Time Operations Centre (RTOC). Working hand-in-hand with our Operational Communications Centre (OCC), the RTOC has senior police officers monitoring policing operations in real-time, assessing ongoing incident risk, coordinating specialized and expert resources, and managing the response. The existence of the RTOC provides our members real-time guidance, direction and support from seasoned and experienced police officers. The RTOC also ensures a coordinated response to cross-jurisdictional activities and significant events through enhanced interoperability with other policing agencies within the Province.

The attached reporting along with your valued feedback will help ensure that our service delivery to your community is meeting you needs on an ongoing basis. As the Chief of Police for your community, please do not hesitate to contact me if you have any questions or concerns.

Priority 2	Reduce Substance Abuse
Current Status & Results	In Q4, Search warrants were executed at two residences in the Town of Barrhead based on intelligence received. Both were well known to the police and the public as drug houses. Members seized large quantities of a variety of drugs including meth, cocaine, fentanyl and heroin. Cash, firearms and stolen property were also seized. The stolen property was linked to several theft files which cleared those matters as well. Four persons charged with a variety of offenses with one in custody. In Q4, members continued to conduct curfew and compliance checks. 58 checks were documented resulting in four new charges. Discretion was also exercised in numerous instances. We are still seeing most breach and FTA charges withdrawn by Crown and this was brought to the attention of the District by Sgt. Dodds.

Trends/Points of Interest

Crime stats went up during the last quarter. The biggest increases were Theft Under \$5000 (45 this year vs. 32 last year) and Fail to Comply & Breaches (17 vs. 9). The increase in FTC and Breaches is due to proactive efforts of detachment members in checking on curfews and other release conditions. The largest drivers in thefts this quarter were catalytic converters and copper thefts. The catalytic converter thefts will be addressed through a new program in concert with Rural Crime Watch and BARCC which will see catalytic converters engraved with vehicle identification numbers at dealerships and repair shops.

Person Crime numbers increased by 1 from last year and were the second lowest for the past five years.

1.0 PURPOSE:

For Town Council to entertain a request to allow an intersection crosswalk painted in indigenous symbols.

2.0 BACKGROUND AND DISCUSSION:

The Barrhead and Community Indigenous Event Committee, on behalf of the Barrhead & District FCSS Society has submitted a letter to Town Council requesting authorization to paint a crosswalk in indigenous symbols.

The proposal is to paint the crosswalk at the 50th street 50th avenue intersection – crossing main street. A sample of a painted crosswalk is attached to the report.

MEMORANDUM TO COUNCIL

Scott Robins – Community Member/Gov of AB Savannah Belyk - FCSS

Indigenous members of the community had approached FCSS Community Coordinator, Trisha Enman to request assistance in organizing this years Walk for Reconciliation, on National Indigenous Day, from the Town Office to the Gazebo. A small group had taken part in something similar last year but had difficulty bringing awareness to the event. Being that Barrhead and District FCSS Society's mission statement includes providing programs and services that strive to enhance and strengthen individuals, families, and the community, we were excited to assist with this event. FCSS goals also include youth seeing themselves as valued members of the community, community awareness of social issues, connectedness and empowerment for all members of the community.

Through conversations, referrals and professional connections, a committee of personally invested individuals was created. It was important that the committee consisted of Indigenous people, as well as people invested in supporting the reconciliation efforts were leading the decisions. This ensures that the culture integrity is maintained and that decisions are made in the best interest of the Indigenous people in our community.

They, and BCHS are supporting the committee by creating pin designs for the upcoming fundraising efforts. Due to the increasing interest in the event, the committee has also started seeking sponsorship from various groups, grants, and businesses, to cover the travel costs, meals and required honorariums for our performers. Efforts to cover these costs are still in motion.

The committee was later approached by a community member offering support in sponsoring a crosswalk, representative of Reconciliation and Indigenous culture. A request for approval was submitted to the town. The committee will not be maintaining it on a regular basis, however, has expressed interest in redoing it in the fall for Truth and Reconciliation on September 30th.

The committee does not have concrete plans for further events at this time but are open to participating in community initiatives.

We appreciate the support from the Town of Barrhead.

Last week, Mayor McKenzie and I met with some members of the Committee to discussed the painted crosswalk. The proposal painting was design by the Committee along with members of the Alexander First Nation. Our Administration also forward the proposal to the Alexis First Nation but at the time of preparing this report, we have not received a formal reply. Based on our conversation with the Committee members we felt confident that the design would be acceptable by all. Our committee had been approached by community members offering to support the painting of a crosswalk on Main Street. We feel that this is a very progressive and respectful way of acknowledging the Indigenous People in our community and the larger region. This allows Barrhead to be a leading community in recognizing and celebrating Indigenous culture.

When asked what we envisioned for symbolic artwork that would respectfully honor and represent the diverse Indigenous culture, we suggested the multi symbolic template that had been utilized by the Town of Whitecourt. This collection of symbols consists of the Eagle Feather, Metis Infinity Symbol and the Inukshuk. The white eagle feather represents First Nation people. It is believed that the eagle is sacred because it flies closest to the Creator. It is a symbol of respect, honour, strength, courage and wisdom. Its feathers also symbolize a step forward, a new chapter in the ongoing story of Reconciliation. The Metis Infinity symbol represents the coming together of two distinct and vibrant cultures, those of European and Indigenous North America. It represents the immortality of the nation. The Inukshuk is representative of the Inuit people. Inukshuk means "in the likeness of a human". It has been transformed into a symbol of hope and friendship that transcends borders to reach people all over the world.

We have asked that a second Eagle Feather be added to the artwork. The fourth symbol balances the art, to represent the 4 directions. North, South, East and West. By honoring the 4 directions, the sidewalk becomes representative of Mother Earth. The color orange was first used in the "Every Child Matters". It has since grown to represent communities coming together in the spirit of Truth and Reconciliation.

The United Church has graciously offered to cover the costs and supply the templates for the symbols. We anticipate repainting the crosswalk prior to Truth and Reconciliation Day in September.

The walk will commence at the Town Office. However, to ensure the safety of the participants, we have confirmed with Blue Heron Support Services, that the area across the street from the town, beside their Gazebo can be utilized. We are anticipating large numbers, as the Elementary School has expressed great interest in being a part of this important celebration. It is a wonderful opportunity to allow the students to actively participate in an event to gain a better understanding of the Indigenous Culture. 

The Town of Barrhead Chief Administrative Officer or his designate will be responsible for the review and approval of Special Events held within the Town and will ensure that those organizations wishing to host a special event will be required to submit in writing information outlining time, date and location of the event. Those requests that require Council approval shall be brought to a regular Council meeting for consideration.

In addition, all necessary permits and bylaws will be reviewed with all other vested departments. i.e. fire department, Community Peace Officer, RCMP, health services, parks and recreation and public works.

PURPOSE:

To ensure a successful and safe event held within our community.

SPECIAL EVENTS PROCEDURE POLICY

Effective Date: September 25, 2018

PROCEDURES:

This Policy is intended to provide guidelines and requirements when hosting a special event within the Town of Barrhead.

1.0 DEFINITIONS

"Council" means the duly elected officers of the Town of Barrhead and the Chief Elected Officer or Mayor.

"CAO" means the Chief Administrative Officer for the Town of Barrhead, and his/her duly authorized designate(s).

"Special Event" means any public or private event not considered a yearly event pursuant to Policy 32-010, held in or on a Town street, facility or park, including but not limited to:

Street Festivals Concerts Trade Shows Exhibitions Rodeos Community sports events Circus Carnivals Fairs

"Town" means the corporation of the Town of Barrhead.

2.0 PROCESS

- 2.1 When making a request to hold a special event within the Town limits, provide in writing on a form provided by the Town, the date, times and location of event, type of event and anticipated number of people attending and any other supporting information.
- 2.2 The CAO or his designate will review special event requests and may consult with the RCMP, Peace Officer, Fire Department or a Town department prior to rendering a decision. Those requests that require Council approval shall be brought to a regular Council meeting for consideration.

3.0 STREET CLOSURE PROCEDURE

3.1 Any request for street closure shall be submitted in writing to the CAO. Any new road closure requests not included within Policy 32-010 will need Council

approval. It is recommended that a request be provided to the Town a minimum of 60 days prior to the event.

Procedure to Policy

4.0 INSURANCE

- 4.1 A minimum of 30 days prior to the special event the organizer must provide to the Town proof of general liability insurance of no less than \$2,000,000, naming the Town of Barrhead as an additional insurer.
- 4.2 The event organizer shall hold the Town harmless from and against all liability, loss, costs, damage or expense arising from use of the Town roads and/or facilities or from any accident or other occurrences, causing injury to any person or property and will protect indemnify and hold harmless the Town from any and all claims, costs or expenses arising from any requirements and provisions agreed to and required by law or ordinance, during the event.

5.0 GENERAL

- 5.1 The special event organizer shall adhere to all Town bylaws, policies and regulations when hosting the event.
- 5.2 The event organizer shall submit all information regarding the event a minimum of 60 days prior to the event in order to allow the Town time to review.
- 5.3 The event organizer shall ensure adequate personal/volunteers are available for the setup and clean up of the venue used for the event.
- 5.4 The event organizer shall ensure adequate personal/volunteers are available for security purposes at the event.
